 2. Please be sure to double check spelling, grammar, layout and design before approving artwork. It is the customer's responsibility to ensure that the proof is correct in all areas. We will not be held responsible for any errors on printed/embroidered products after final approval.
 3. We do not carry responsibility for freight/courier companies that may delay delivery of your finished goods.
 4. Colours generated on an electronic device such as a computer, may appear differently and are not an accurate example of the final product. Further we cannot guarantee against colour loss and shrinkage or against damage to weak and tender fabrics.
 5. Photos of garments or articles, templates and positions are for visual purposes only. The final product may differ. Please ask us to provide to you a sample or view a colour chart if required.
 6. Please check the garment colour, size measurements and size breakdown on tax invoice which you have ordered. There will be no refund on our services in the event that you have ordered the wrong size or colour.
 1. All sizes, weights and measurements provided in catalogues are approximate and for ease of reference only. Please note 100% cotton garments do shrink. Washing instruction labels must be followed for maintenance.
 - 8 Customer has 24hour cooling period to cancel the order after the artwork is email. Five artwork changes are free of charge.
Desposit (30%) will be not non-fundable.
 - 8 In the event the customer cancels the order 24hours after the artwork is approved, we are nonetheless entitled to receive the balance due remittance for services rendered on dispatch/ collection of goods.
- 9**UniformMart will assume absolutely no liability for any of the following not follow by customer:
- a) Machinery fault which causes damage to any garments or articles provided by you the customer, or responsibility for inherent weaknesses of or defects in all materials that are not readily apparent prior to processing; and/or

1. Any alleged damage incurred must be reported via email or fax within 3 working days from receiving the finished goods by the customer.

Of course it may be that a manufacturing fault or failure of a component, for example incorrect stitching, faulty dyes, faulty or broken buttons etc, has caused the embroidery process to damage the garments or articles, in which case the garments or articles it should be referred to the retailer or manufacturer for their assistance.
