# AGREEMENT BETWEEN D&I SHOPFITTING & KOMACHI JAPANESE

The Agreement between <u>KOMACHI JAPANESE</u> and D&I SHOPFITTING FAMILY TRUST (the "Agreement") is effective the date of <u>23 AUGUST 2022</u> D&I Shopfitting Family Trust (the "Contractor"), a company organized and existing under the laws of the QLD, with its head office located at:

U1, 73-75 STEEL STREET CAPALABA QLD 4157.

KOMACHI JAPANESE (the "Owner"), a company organized and existing under the laws of the QLD, with its located at <u>T3A</u>, <u>Coomera City Centre, City Centre Drive, Upper Coomera QLD 4209</u> WHEREAS, Owner finds that the contractor is qualified to perform the work, all relevant factors considered, and that such performance will be in furtherance of Owner's business.

NOW, THEREFORE, in consideration of the mutual covenants set forth herein and intending to be legally bound, the parties hereto agree as follows:

#### 1. MATERIAL AND LABOUR PROVIDED

The contractor agrees to provide all of the material and labor required to perform the following works:

The Contractor agrees to provide and pay for all materials, tools and equipment required for the prosecution and timely completion of the work. Unless otherwise specified, all materials shall be new and of good quality.

In the prosecution of the work, the Contractor shall employ a sufficient number of workers skilled in their trades to suitability perform the work.

#### 2. PAYMENT

The Owner hereby agrees to pay the Contractor, for the aforesaid materials and labour, the sum of \$ 143,000 (inc. GST) in the following manner:

10% of the total amount

40% of the total amount

10% of the total amount

Handover date

## 3. WORK SCHEDULE AND COMPLETION OF THE WORK

The Contractor agrees that the entire work shall be completed no later than <u>6 weeks</u> after starting at the site work commenced under no bringing issues from plumbing, electrical and approval parts of the works.

## 4. MODIFICATIONS TO THE WORK

All changes deviations in the work ordered by the Owner must be in writing, the contract sum being increased accordingly by the Contractor. Any claims for increases in the cost of the work must be presented by the Contractor to the Owner in writing, and written approval of the Owner shall be obtained by the Contractor before proceeding with the ordered change or revision.

#### 5. ACCESS

The Owner, Owner's representative and public authorities shall at all times have access to the work.

## 6. COMFORMITY WITH DRAWINGS AND SPECIFICATIONS

The Contractor agrees to re-execute any work which does not conform to the drawings and specifications, warrants the work performed, and agrees to remedy and defects resulting, from faulty materials or workmanship which shall become evident during a period of one year after completion of the work.

### 7. INSURANCE COVERAGE

The Owner agrees to maintain full insurance on the above-described work during the progress of the work, in his own name and that of the Contractor.

The Contractor agrees to obtain insurance to protect himself against claims for property damage, bodily injury or death due to his performance of this agreement.

### 8. DELAYS

In the event of the Contractor is delayed in the prosecution of the work by acts of God, fire, flood or any other unavoidable casualties; or by labour strikes, late delivery of materials; or by neglect of the Owner; the time for completion of the work shall be extended for the same period as the delay occasioned by any of the aforementioned causes.

#### 9. NO ASSIGNMENT

Neither the Owner nor Contractor shall have the right to assign any rights or interest occurring under this agreement without the written consent of the other, nor shall be the Contractor assign any sums due, or to become due, to him under the provisions of this agreement.

### 10. GOVERNMENT LAW

This agreement shall be interpreted under laws of the QLD.

# 11. ATTORNEY'S FEES

Attorney's fees and court costs shall be paid by the defendant in the event that judgment must be, and is, obtained to enforce this agreement or any breach thereof.
